4. FIRST-AID MEASURES

Inhalation

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. Evacuate all unprotected personnel. If possible contain the spill. Spillage may be slippery. As a water based product, if spilt on electrical equipment the product will cause short-circuits. Place inert, absorbent material onto spillage. Use clean tools to collect the material and place into suitable labelled containers for subsequent recycling or disposal. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Maintain high standards of personal hygiene by washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Protect from freezing. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Occupational exposure limit values

Safe Work, Australia Exposure Standards:

Potassium hydroxide

TWA: 2 mg/m³ (Peak limitation)

TWA (Time Weighted Average): The average airborne concentration of a particular substance when calculated over a normal eight-hour working day, for a five-day week.

STEL (Short Term Exposure Limit): The average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

Peak Limitation: A ceiling concentration which should not be exceeded over a measurement period which should be as short as possible but not exceeding 15 minutes.

Biological Limit Values

No biological limits allocated.

Appropriate Engineering Controls

This substance is hazardous and should be used with a local exhaust ventilation system, drawing vapours away from workers' breathing zone. If the engineering controls are not sufficient to maintain concentrations of vapours/mists below the exposure standards, suitable respiratory protection must be worn.

Respiratory Protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable vapour/mist filter should be used.
